ENTRY DOOR CERTIFICATION STATEMENT

Winchester Industries, headquartered at 500 Leech Avenue, Saltsburg, PA 15701, manufactures exterior windows and doors that meet or exceed the prescribed criteria as set forth in the Federal Economic Stimulus Package, The American Recovery and Reinvestment Act of 2009. The eligibility guidelines require that exterior windows and doors have both a U-Factor equal to or less than 0.30 and a Solar Heat Gain Coefficient (SHGC) equal to or less than 0.30 in order to qualify for a tax credit. The tax credit amount is now 10 percent of the cost of building envelope improvements, excluding labor costs and limited to \$200 for windows. There is a cap on the credit amount of \$500 for fiscal years 2006 through 2011 combined; if you have ever claimed this credit in the past, it counts against the \$500 limit (but does not affect the \$1500 limit available for 2009 and 2010). So, for example, if you claimed \$300 in 2007, you can only claim \$200 in 2011; if you claimed \$800 in 2009, you cannot claim any more credit.

When is it available? The home improvements tax credit applies for improvements "placed in service" from Jan. 1, 2011, through Dec. 31, 2013. The IRS defines "placed in service" as when the products or materials are ready and available for use – this would essentially always refer to the installation, not the purchase.

Many of Winchester's quality exterior steel door systems, housed in a new construction wood frame, meet or exceed the prescribed criteria, referenced above, and therefore qualify. Limited models qualify in steel frame application -see below. Specifically, the following WI Entry Door Systems comply:
